THE CUSTOMS, GOLD (CONTROL) AND CENTRAL EXCISES AND SALT (AMENDMENT) ACT, 1973 No. 36 of 1973

[1st September, 1973]

An Act further to amend the Customs Act, 1962, the Gold (Control) Act, 1968 and the Central Excises and Salt Act, 1944.

BE it enacted by Parliament in the Twenty-fourth Year of the Republic of India as follows:-

CHAPTER I

PRELIMINARY

1. This Act may be called the Customs, Gold (Control) and Central Short Excises and Salt (Amendment) Act, 1973.
